NOTIFICATION

Subject:-Engagement of Part time lady doctors at Miraj & Satara Railway Health Units.

It is decided to engage part time lady doctors at Miraj & Satara Railway Health Units on contract basis.

The terms and conditions for engagement are as follows.

1. Lady doctors on part-time basis (referred to hereunder as part-time contract lady doctor) are being engaged on contract for two hours daily (One post at Miraj railway health unit & one at Satara health unit)
The part time contract lady doctor should work in the morning OPD hours for two hours from 10 AM to 12 Noon
2. Minimum qualifications required is MBBS with completion of compulsory Internship.
3. The contract shall be entered into for one year from the date of entering into the contract. Period of contract is not extendable on any grounds. However, the railway administration shall reserve the right to enter into fresh contract for one year or less with the practitioner on further contracts.
4. Part-time contract lady doctor who enters into contract with the railways will not have any claim or right for his/her continuity.
5. During the validity of the contracts, the part time lady doctor or the railway administration will be at liberty to terminate the contract by giving 15 days notice at any time during the contract without assigning any reasons whatsoever. The contract shall also be terminated forthwith, if the contract lady doctor is found to be mentally or physically incapacitated.
6. The part time lady doctor shall be of good general health.
7. Minimum entry age limit of candidate for appointment as part time contract lady doctor shall be 53 years and maximum age limit shall be 65 years of 12 terms whichever is earlier and each term of engagement shall not exceed more than one year. Any lady doctor engaged as part-time contract lady doctor shall cease to be on contract on her attaining the age of 65 years.
8. Normally Sundays and National Holidays will be off.
9. The monthly fee of part-time contract lady doctor and the daily rate of proportionate reduction from the fee in the event doctor absents herself for a period exceeding those stipulated in the contract are at the following rates.

a. Monthly Remuneration

Part-time contract for two hours---Rs. 18500/-

b. Proportionate reduction per day of absence:

Part-time contract for two hours---Rs. 617/-

- 10.The part time contract lady doctor shall be governed in respect of matters not referred to in these terms and conditions by any orders/amendments to the terms of contract issued by the railways from time to time.
- 11.The part time contract lady doctor shall not exercise any financial powers.
- 12.The part time contract lady doctor shall not initiate /review/accept the annual confidential reports of Group 'C' railway employees.
- 13.The part time contract lady doctor shall not indent or condemn/recommend for condemnation any tools and plants.
- 14.The part time contract lady doctor will be available in the Railway Health Unit during the contract hours daily and will attend to Railway beneficiaries only. During the prescribed hours of duty, the part time contract lady doctor shall not attend to any private patient or shall not leave the premises of the Unit in which she is engaged, except with the permission of the head of the unit.
- 15.The part-time contract lady doctor will be required to examine all patients attending to her, preferably lady patients and children and prescribe suitable medicines and conduct procedures expected from MBBS doctors.
- 16.The part-time contract lady doctor is not eligible for any Railway pass (Privilege/complementary pass) as per extant orders.
17. At the time of entering into contract , the part time contract lady doctor shall produce certificates of her character and antecedents from two gazette officers of the central/state government.
- 18.At the time of entering into contract, the part time contract lady doctor shall produce original certificates of her date of birth and educational qualifications.
19. The part time lady doctor shall attend to all normal tasks which any medical practitioner is conventionally doing. She will also attend to emergencies and accidents.
- 20.The part time contract lady doctor shall not make medical recommendations of any kind referred to paras 559 to 564 of Indian Railway Medical Manual (IRMM), 2000.
- 21.The part time contract lady doctor shall not exercise any financial powers including operation of imprest account. Operation of imprest account in exigencies shall be done by the Railway Medical Officer of the nearest Health unit/dispensary/Hospital.
- 22.Walk-in interview to fill the posts will be conducted at Divisional Railway Hospital Maldhakka Road Pune 411001, in the chamber of Chief Medical Superintendent on 01.7.2019 at 10.30 am. Candidates should attend with all relevant documents with attested copies for verification & should be present one hour before the walk in interview starts. No other information will be given separately for interview.**
